Jerry Brown informed the council that the walk bridge has been delayed due to the sewer line needing to be moved 2 feet.



Mark Snow made a motion to spend \$1,000.00 for Christmas decorations, seconded by Ronald Nelson and the vote was unanimous.



Minutes of the previous meeting were read and approved. Treasurer's report was presented and accepted.

Minutes of the previous meeting were read and approved. Treasurer's report was presented and accepted.





Treasurers report was given and accepted.






The application for the WV DOH money for new sidewalks has been submitted.

Asbestos abatement will cost \$1,938 for the Cleve Cooper property.


Motion was made by George Chafin to purchase a new copier for City Hall in the amount of \$3,928.00, seconded and the vote was unanimous.


Ribbon cutting on the new Walk bridge is set for July 8<sup>th</sup> 5 pm.



Minutes of the previous meeting were read and approved.


The minutes of the previous meeting were read and approved. The treasurers report was given and accepted.




George Chafin made a motion to accept the ATV Ordinance as presented on the first reading, seconded by Harold Porter and the vote was unanimous.




George Chafin made a motion to award the attendance bonus to employees up to \$1,000.00, pro rated, Fred Byrnside seconded, and the vote was unanimous.




