Ronald Nelson made the motion to read minutes. Bill Mullins Seconded, and the vote was unanimous.


Roger McNeely was sworn in by Mayor Mark McClure as city councilman.

Presentation was presented by Susan Economou about home rule. Discussion followed.


George Chafin made the motion to pay all current bills. Bill Mullins seconded the motion and the vote was unanimous.



Councilmen: Bill Mullins II, Mark Snow, Roger McNeely, George Chafin, and Ronald Nelson.


George Chafin made the motion to accept the revision to the B&O tax rates. Roger McNeely seconded the motion, and the vote was unanimously passed.

The council of the Town of Danville met in special session with the following members present: Mark McClure, Mayor; Anthony Carrico, Town Recorder.


Councilmen: Bill Mullins II, Mark Snow, Roger McNeely, George Chafin, and Ronald Nelson.


Roger McNeely made the motion to read the B&O tax rates. Ronald Nelson seconded the motion and vote unanimously was passed.



The council of the Town of Danville met in special session with the following members present: Mark McClure, Mayor; Anthony Carrico, Town Recorder.


Councilmen: Bill Mullins II, Mark Snow, Roger McNeely, George Chaffin, and Ronald Nelson
